

## **2019 Beef ‘O’ Brady’s “Kids Art” Sweepstakes**

1. SWEEPSTAKES DATES: July 15, 2019 – August 4, 2019.

2. HOW TO ENTER:

- A. Make your own picture OR color Paddy on the sheet your family received in-store from Beef ‘O’ Brady’s.
- B. Bring your picture or sheet with Paddy colored into any Beef ‘O’ Brady’s location during Sweepstakes Dates.
- C. Get a golden ticket (while supplies last). At Sweepstakes participating locations the golden ticket includes an entry form to be filled out by your parent.
- D. At participating locations, rip the entry form off the golden ticket and put in the ballot box at the Beef ‘O’ Brady’s location.

3. ENTRY LIMITS & RESTRICTIONS: Entry form on golden ticket must be used to enter. Copied entry forms are NOT allowed. Limit of one (1) entry per person at any Beef ‘O’ Brady’s location within a three (3) hour period. Entries become property of Sponsor and will not be returned.
